#### Discussion of process and timeline for a new course or a course that is no longer approved for CSU GE

**Process:** Scarlet and Letrisha will put together a statement to be included in the email that Ana sends out to the faculty in preparation for Technical Review. The statement will include the GE process as below.

1. For a new course, or a course that has gone through substantive change, or when a course fell out of the CSU GE approval – the faculty/department needs to complete the MC GE Template.
2. The completed MC GE Template must be submitted to the GE workgroup prior to next GE meeting.
3. If the GE Template is not received by the timeline (when the course is placed on Curriculum Committee Agenda), the course will be removed from the GE worksheet for the following next academic year.
